How will I survive financially?

If you have relied on the financial support of your partner or spouse throughout the relationship, then managing money will be a huge concern. Family law legislation is there to provide for people who find themselves without the financial support they have relied upon throughout a relationship.

Between spouses there is an obligation to provide continuing financial support in circumstances where one spouse needs that support, and the other can afford to provide it. This is referred to as 'Spousal Aliment'.

It can be sought through a Court order if the spouse who can afford to provide financial support refuses or delays to do so.

Additional orders can be sought through the Court to protect your financial position, for example, to ensure that one party contributes towards their share of certain financial obligations. The ability to maintain mortgage payments, or inability to pay the mortgage at all, might be a major concern. The court can make an order to ensure that the party who can afford to pay the mortgage will meet that payment, whether they are residing in the matrimonial home or not.



Every case is dependent upon its own facts and circumstances. There are many practical options to be considered when it comes to financial survival in the shorter term. Alternative housing, potential entitlement to government assistance, budgeting household outgoings. It helps to seek advice and talk to someone about the issues you are concerned about.
